On October 7, 2014, a class action lawsuit was filed in Los Angeles Superior Court against the defendant skilled nursing facilities and related parties listed below. The case was later re-filed as a class arbitration with Judicial Arbitration & Mediation Services (JAMS) in Orange, California. The short name of the case is *Foreman v. Shlomo Rechnitz, et al.*, JAMS Reference No. 1220052954.
